TERMS & CONDITIONS PROGRAM "GREEN ACTION – GREEN FUTURE"

These Terms and Conditions are effective from April 1, 2024

- (c) The Bank is not responsible for notification via phone number or email address of the Customers registered with the Bank is not successfully sent, when the Customers do not provide and update the correct information, or the email is transferred to spam (Spam / Junk); and when the Customers' telecommunications service provider uses notification blocking from the Bank for any reason.
- (d) The Customers are responsible for paying all relevant taxes and fees (including but not limited to personal income tax), if any, in accordance with applicable laws arising from the Customers' receipt of material benefits for participating in the Program.
- (e) For disputes arising in connection with the Program, the Bank and relevant partners will resolve them in cooperation with the Customers. In case the parties fail to reach an agreement, the dispute will be resolved in accordance with the provisions of Vietnamese law.
